

## NON-REVENUE USER AGREEMENT

As an authorized representative of an organization or entity that desires to establish one or more Non-Revenue Account(s) with the North East Texas Regional Mobility Authority, I have read the applicable portions of Sections 362.901, 370.177, and/or 372.052 Texas Transportation Code, which govern free passage of toll roads by military vehicles, authorized emergency vehicles, and vehicles used for emergencies by nonprofit disaster relief organizations.

I am providing to the NET RMA the License Plate Numbers held by my organization or entity that qualify for a Non-Revenue Account pursuant to Sections 362.901, 370.177, and/or 372.052 Texas Transportation Code, as described further below:

1. Section 362.901, Texas Transportation Code, provides an exemption from toll payments for military vehicles, including unmarked military vehicles operated by military personnel conducting an emergency preparedness, response, or recovery operation or participating in a training exercise for an emergency preparedness, response, or recovery operation. The term does not include a vehicle operated for personal use.
2. Section 370.177, Texas Transportation Code, provides an exemption from toll payments for authorized emergency vehicles as defined by Section 541.201, Texas Transportation Code. Section 541.201 defines "authorized emergency vehicle" to include:  
  
(A) a fire department or police vehicle; (B) a public or private ambulance operated by a person who has been issued a license by the Texas Department of Health; (C) a municipal department or public service corporation emergency vehicle that has been designated or authorized by the governing body of a municipality; (D) a private vehicle of a volunteer firefighter or a certified emergency medical services employee or volunteer when responding to a fire alarm or medical emergency; (E) an industrial emergency response vehicle, including an industrial ambulance, when responding to an emergency, but only if the vehicle is operated in compliance with criteria in effect September 1, 1989, and established by the predecessor of the Texas Industrial Emergency Services Board of the State Firemen's and Fire Marshals' Association of Texas; (F) a vehicle of a blood bank or tissue bank, accredited or approved under the laws of this state or the United States, when making emergency deliveries of blood, drugs, medicines, or organs; or (G) a vehicle used for law enforcement purposes that is owned or leased by a federal governmental entity.
3. Section 372.052, Transportation Code, provides an exemption from toll payments for a vehicle registered under Section 502.203 (now re-designated as Section 502.454), Transportation Code, which includes a commercial motor vehicle, trailer, or semitrailer owned and used exclusively for emergencies by a nonprofit disaster relief organization.

By providing the enclosed License Plate Numbers, I and all employees of the organization or entity that I represent agree to the following: .

The License Plates Numbers provided **are not for personal or private use** and may not be transferred, loaned or otherwise used by anyone other than the authorized users.

To the extent of any conflict or inconsistency between our organization's internal policy regarding use of these License Plates Numbers and the terms and conditions of this agreement, this agreement shall control.

By providing the License Plate Numbers, I and all employees using the NET RMA system agree to abide by the terms and conditions set forth in this letter.

I or another authorized representative of my entity or organization will provide updates to the License Plate List whenever a new vehicle is put into service and/or vehicle license plates are removed or taken out of service.

On a yearly basis, my organization or entity will permit the NET RMA to audit use of the License Plate imaging.

This agency agrees to abide by the requirements of Texas law while utilizing NET RMA toll facilities.
